## **NOTIFICATION**

WHEREAS, SIA Notification **NO. F. 09 (01)-REV/ACQ/XIII/17**

dated the **07-02-2017** under **Sub-Rule 4 of Rule 3** of "the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Rules, 2015", relating to the land/lands measuring **31.89** acres in Mouza **Doulbari** of **Sabroom** Tehsil was issued by the Government.

AND WHEREAS, the possession of **entire land measuring 31.89 acres** has not been taken over by the Government as, the land in question is no longer needed by the Requiring Department;

NOW, THEREFORE, in exercise of the power conferred by Sub-Section (1) of Section 93 of "the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013" the Government hereby withdraws from the acquisition of the said land/lands as described in the schedule below.


